Good news for historic preservation

More federal funds available

reservationists across the nation have reason to celebrate this year. The federal government's Historic Preservation Fund for the states received a \$15 million increase for 2001. Minnesota's share of the full \$46.6 million appropriation is \$948,084 - an increase of more than 50 percent over funding levels of the past decade. A vote of confidence from Washington, the increase reaffirms the value of our nation's historic resources and the unique partnership between state, local, tribal and federal governments that framers of the National Historic Preservation Act envisioned.

Historic Preservation Office (SHPO) in many ways. Monies, which must be matched with nonfederal sources, are used for historic property surveys, nominations to the National Register of Historic Places, reuse studies for threatened or underused National Register properties, resource protection planning, local government preservation programs, technical assistance to private parties on preservation and protection matters, development of historic properties and the monitoring of compliance with federal historic preservation requirements.

A portion of Minnesota's appropriation each year is awarded in matching grants to local governments

GRANTS DEADLINES

During the 2001 winter grants cycle, applications will be accepted for federal Certified Local Government grants and the State Grants-in-Aid program. For more information call the grants office, 651-296-5478.

SAVED

Roseau County: Canadian National Depot (1914), Warroad. Warroad's depot, now used for city offices, was rehabilitated in part with a grant from the State Capital Grants-in-Aid program. Work included reconnecting large wooden brackets at the eaves, cleaning exterior brick, repointing deteriorated mortar and installing drain tile to eliminate standing water in the basement.

Goodhue County: District #20 School (1889), Hay Creek Township. Also the beneficiary of grant funds from the State Capital Grants-in-Aid program, the District #20 School received a new roof, fascia, windows and accessible entrance. Inside, wood floors were refinished, the false ceiling removed and the electrical system upgraded. No longer used as a school, the building now serves as a polling place and a meeting site for the township board, local planning commission and 4-H club.

Hennepin County: East Lake Branch Library (1924), 2916 E. Lake St., Minneapolis. Prepared by Sue Granger and Kay Grossman.

Hennepin County: Franklin Branch Library (1914), 1314 W. Franklin Ave., Minneapolis. Prepared by Sue Granger and Kay Grossman.

Hennepin County: Sumner Branch Library (1915), 611 Emerson Ave. N., Minneapolis. Prepared by Sue Granger and Kay Grossman.

The Italian Renaissance Revivalstyle Franklin Branch Library (right) and the Tudor Revival-style Sumner Branch Library (far right) are two of 14 Minneapolis Public Library branch buildings built or acquired between 1894 and 1936. They are among four libraries in the city built with Carnegie funds. Both are closely associated with

the career of Gratia Alta Countryman (1866–1953), a leading figure in the development of the public library movement nationwide.

Countryman served as head of the Minneapolis Public Library from 1904 to 1936, a period during which the institution established most of its Sumner Branch Library, Minneapolis.

In addition to her library career, Countryman was active in many civic organizations, particularly those that addressed social welfare.

Capital grants awarded

unded by the Minnesota Legislature, the capital grants program assists county and local jurisdictions with historic preservation projects of a capital nature. During the fiscal year 2001 fall grants cycle, sixteen grants totaling \$383,590 were awarded throughout the state.

Beltrami County: *Beltrami County, Bemidji.* \$30,000, east entrance restoration, phase 2, Beltrami County Courthouse.

Carlton County: *Carlton County Historical Society, Cloquet.* \$20,000, electrical system upgrade and HVAC installation, Shaw Memorial Library.

Carver County: *City of Carver.* \$18,758, restoration, Presbyterian Church.

Chippewa County: *Chippewa County Historical Society, Montevideo.* \$24,000, restoration, Olof Swensson Barn.

Hennepin County: City of Robbinsdale. \$18,000, mechanical/electrical upgrade, Hennepin County Library, Robbinsdale Branch.

Lincoln County: *Lincoln County, Ivanhoe.* \$25,000, tuckpointing, Lincoln County Courthouse.

St. Louis County: *City of Duluth.* \$25,000, restoration, Lincoln Park Bandstand.

St. Louis County: *City of Bubl.* \$25,000, tuckpointing and exterior restoration, Buhl Public Library.

Sibley County: *Board of Commissioners for Sibley County, Gaylord.* \$50,000, dome restoration,
Sibley County Courthouse.

Steele County: *City of Owatonna*. \$31,650, tuckpointing and exterior restoration, State School for Dependent and Neglected Children.

and nonprofit organizations. This year these funds will be awarded during the winter grants cycle (see calendar, page 2). Federal regulations require that at least 10 percent of the annual allocation be awarded as pass-through grants to cities with Certified Local Government (CLG) status. For 2001, up to \$110,000 will be awarded to CLGs; eligible cities have already been notified of the increase. In addition, up to \$25,000 will be used to augment the winter-cycle State Grants-in-Aid program, funding historic structures reports for National Register properties. For more information call the grants office at 651-296-5478.

These increases couldn't have come at a better time for Minnesota. The funds will help jump-start initiatives of the statewide historic preservation plan issued last September. Be sure to let your congressional representatives know that this generous appropriation will make a big difference for historic preservation in Minnesota. We owe them our thanks.

Funds available for reuse studies

Help for threatened properties

ach year the State Historic
Preservation Office sets aside funds
from its annual appropriation for reuse
studies that examine potential uses for
threatened historic properties. In 2001
approximately \$25,000 has been
earmarked to assist up to 10 studies.

Projects meeting the following criteria are eligible:

- The property must be listed, or eligible for listing, on the National Register of Historic Places and must be threatened, vacant or underused.
- The applicant must be a unit of government, public agency or nonprofit organization willing to host the reuse study team, facilitate the process and assist in preparation and presentation of the report. Matching funds and/or services for these activities are required.

• The applicant must demonstrate an ability and commitment to implement recommendations made in the study.
