

Hubert H. Humphrey Digitization Project Sound File Metadata Guidelines, June 25, 2013

Files created for the Hubert H. Humphrey digitization project will adhere to the Federal Agencies Digitization Guidelines Initiative (FADGI) document entitled "Embedding Metadata in Broadcast WAVE Files" approved by the Federal Agencies Audio Visual Working Group (FAAVWG) in April of 2012.

For the Humphrey project, we are using <u>BWF MetaEdit</u>, "a free, open source tool that supports embedding, validating, and exporting of metadata in Broadcast WAVE Format (BWF) files, including support for the Federal Agencies guideline." The files can be opened in BWF MetaEdit, and the metadata can be manipulated manually, field by field, or imported through a spreadsheet.

If a digital audio file was created by another institution, it is possible that the file will have some embedded metadata upon delivery. Some of the metadata will need to be replaced and some can stay as is. For instance, the OriginatorReference will need to be replaced, as it is the filename that we assign. Originator and Description fields can stay as they were upon delivery. If metadata exists in fields we typically wouldn't use, it can also stay as is. However, if the BWF MetaEdit tool indicates the data is in the wrong format, it should either be removed or corrected. Any other required fields should be replaced with new metadata and the Info Chunk fields should also be replaced.

Regarding any MP3 derivatives made from the Broadcast Wave files, new metadata should be added separate from the information contained in the Broadcast Wave metadata. For the Humphrey digitization project, metadata fields must include the title and date of each speech with a forms part of note, "Hubert Horatio Humphrey (1911-1978)" as the creator, a copyright statement, and the year.

The chart that follows lists each metadata element, a definition of the element, the recommendation of the Audio Visual Working Group oifi the Federal Agencies Digitization Guidelines Initiative, field character limits, Minnesota Historical Society adoptive practive, and an example of the field's content value.
