SCOPE AND CONTENTS OF THE RECORDS

Annual (1909-1956) and biennial (1958-1980) reports; most containing a summary statement of receipts and disbursements, a list of certified public accountant certificates issued in the past year, and comments on the board's activities and on pending legislation. Some contain a cover letter from the board's secretary with additional discussion of the year's work and current issues or problems. Also rules and regulations (1909-1971, scattered), annual directory (1975-1976, 1979), and CPA examination question sets (1909-1913).
