**State by McClure v Department of Corrections, 1977-1986.** 8 folders.

Case brought by the Minnesota Commissioner of Human Rights against the Department of Corrections claiming that the bona fide occupational qualification policy adopted on January 1, 1980 by former corrections commissioner Jack Young discriminated against female correctional counselor employees, in violation of Minnesota Statutes 363.06, by limiting certain counselor positions to males only. Such a decision, the Department of Human Rights argued, resulted in a loss of employment opportunities, transfer and promotional opportunities, and monetary compensation and fringe benefits for female counselors.
