SCOPE AND CONTENTS OF THE RECORDS

Correspondence, legal instruments, and related materials, documenting stipulation agreements that concerned resolving alleged hazardous waste violations and assuring compliance with the laws and rules concerning the management of hazardous waste. A stipulation agreement is an agreement between parties regarding an aspect of a legal proceeding. The actual agreements found in these files occurred between 1984 and 1991 and involved both private companies and local, municipal, and state government bodies.

Correspondence and stipulation agreement, October 1990 - May 1991.</p> <p>Eveleth Taconite Company and Eveleth Expansion Company: Stipulation agreement occurred in 1990. Correspondence and stipulation agreement, March-August 1990.</p> <p>Ford Motor Company: Stipulation agreement occurred in 1990-1991. The Ford Motor Company's Truck Manufacturing Plant in St. Paul was deemed responsible and fined for three spill incidents of hazardous waste into the Mississippi River that occurred in July, August, and September 1989. Correspondence, stipulation agreement, and newspaper clippings, August 1990 - August 1991.</p> <p>FSI International: Stipulation agreement occurred in 1990. Stipulation agreement, February-March 1990.</p> <p>Koch Refinery: Stipulation agreement occurred in 1985-1987. The Minnesota Pollution Control Agency (MPCA) and the Koch Refinery, located in Rosemount, Minnesota, created a stipulation agreement in 1987 designed to resolve three issues between the MPCA and Koch: past non-compliance with hazardous waste rules; clarification of the terms and mechanics of a ground water monitoring program; and a schedule for the exchange of information relative to permit issuance. The agreement required the company to pay a monetary penalty of \$33,000 to the Environmental Response, Compensation and Compliance fund for the alleged noncompliance.</p> <p>Correspondence and stipulation agreement, May-December 1989.</p> <p>Larson Boats: Proposed stipulation agreement, District Court, County of Morrison, 1989-1991.</p> <p>Administrative search warrant, February 1989.
