SCOPE AND CONTENTS

Soldiers' discharge papers (1862-1909), military pension certificates (1882-1904), patent certificates and related papers (1893), change of name papers (1897), court commissioner's record book (1885-1940), record of assignment of judgments (1889-1939), physician's and surgeon's register (1893-1898), and miscellaneous record book (1913-1966). The latter includes registration certificates for dentists, chiropractors, doctors, veterinarians, optometrists, and ministers, and records of power of attorney, business names and partnerships, bankruptcy, naturalizations, marriages, and honorable military discharges.

Location

154.K.4.3B Soldiers' discharge papers, 1862-1909.
Military service discharge certificates or certificates of military service for the following Civil War soldiers: Charles A. Burr (1886); James Clark (1903); William [Cromdale?] (1865); Herman Freitag (1863, 1865); Thomas L. Hall (1982); Abram [Lamien?] (1909); and James Smith (1890). Most served in non-Minnesota units and the papers were issued by other states or the federal government. Apparently filed with the court for safekeeping.

Location

- 154.K.4.3B Military pension certificates, 1882-1904.
For the following Civil War soldiers: Levi D. Bryant (1900); Thomas L. Hall (1897); Thompson Smith (1904); and William L. Wakefield (1882). Most served in non-Minnesota units; the certificates were issued by the U. S. Department of the Interior. Apparently filed with the court for safekeeping.
- Patent certificates and related papers, 1893.
Filed with the court by John L. Spalding for safekeeping.
- Change of name papers, 1897.
For Ludwig C. Dyregrov (from Ludwig C. Anderson), Arnikka Dyregrove (from Arnikka Anderson), and Charles Seavey (from Charles Syverson).

Certificates of registration in the basic sciences (1927-1961; pages 1-13), including from the boards of medical examiners, dental examiners, chiropractic examiners, veterinary examiners, optometry board, and for ordination of ministers. Also, records of power of attorney, business names, bankruptcy, business partnership and a few naturalization, and marriages and honorable discharges from the armed forces (1913-1966; pages 41-192).
