SCOPE AND CONTENTS OF THE RECORDS

Registers of actions for civil (1885-1961) and criminal (1886-1939) cases. Each entry gives the names of the parties in the case, frequently the attorneys representing each party, when the case was opened, the case file number, and a record of each document that was filed by the contesting parties or by the court in the case.

ARRANGEMENT OF THE RECORDS

The records are divided into two sections: civil and criminal. Each section's registers are arranged in case file number order; with each volume including a self-contained index to the cases that references either the page number or the case file number. These indexes may also be used as an index to the county's case files if the plaintiffs/defendants indexes are not available.
