SCOPE AND CONTENTS OF THE RECORDS

Correspondence documenting the programs and activities of the auditor's office under Dayton, particularly its relationship with local and state government officials and legislators, businesses and organizations, and private citizens. Topics of particular interest include the Department of Administration, budget and legislation issues, Northwest Airlines, retirement and pension issues, and the State Board of Investment. The 1991-1993 files include an annual correspondence log listing sender, organization, subject, dates and drafter of letter, with a subject cross reference noting date, under what name the correspondence is filed, and the subject of the letter.

The files are arranged alphabetically by correspondent's last name or by organization.
