#### **ADMINISTRATIVE HISTORY OF THE GOVERNOR'S COMMISSION ON PUBLIC SECTOR EMPLOYMENT CONTRACTS**

The Governor's Commission on Public Sector Employment Contracts was created by Governor Carlson on June 28, 1995 to identify and review compensation plans and employment contracts for highly-compensated officials in state government, cities, counties, school districts, higher education, and quasi-government organizations. The commission was co-chaired by State Auditor Judi Dutcher and Piper-Jaffrey executive Craig Shaver.

#### **SCOPE AND CONTENTS OF THE RECORDS**

The records include meeting packets containing minutes, correspondence, informational materials, and typed meeting transcripts (July - November 1995), and the commission's January 1996 findings and recommendations. There are also two reports on state employee benefits (1994-1995) and University of Minnesota human resources (1995).
