ADMINISTRATIVE HISTORY OF SOUTH CENTRAL EDUCATION DISTRICT NO. 61-6008, MINNESOTA LAKE

South Central Education District was established as No. 6008 on July 1, 1988 under Minn. Stat. 122.91 [Education District Legislation] to ensure collaboration and coordination between participating school districts and increase the educational and developmental opportunities for students, educators, and community members.

The independent school districts involved were No. 72, Mapleton, No. 79, Amboy-Good Thunder, No. 217, Bricelyn, No. 218, Delavan, No. 219, Elmore, No. 222, Keister, No. 223, Minnesota Lake, No. 224, Wells-Easton, No. 225, Winnebago, No. 240, Blue Earth, No. 242, Alden-Conger, No. 243, Emmons, No. 244, Freeborn, No. 245, Glenville, and No. 827, New Richland-Hartland.

The number was changed to 61-6008 and the office moved from Wells to Minnesota Lake during 1989-1990. The district dissolved on June 30, 1996.
