SCOPE AND CONTENTS OF THE RECORDS

Reports, newspaper clippings, newsletters, reprints of articles, copies of legislation, and correspondence concerning various aspects of women's rights, particularly sex discrimination.

Topics covered include discrimination in athletics, education, employment, law, and establishment of credit ratings; media handling of discrimination issues; and the Equal Rights Amendment. Much of the material was gathered from other private and governmental groups with interests similar to the Women's Division. The correspondence of the division's staff concerns complaints of sex discrimination, plans for conferences and meetings, lobbying efforts, and related activities.

Also contained in the records are the minutes and working files of the Women's Advisory Committee and its Women's Skills Bank.
