Coroner's record book (1927-1967), coroner/medical examiner certificates (1978-2004), and coroner's inquest records (1951-1966) and transcripts (1966-1981). The inquest records, many assigned the civil case file number 9617, include inquest certificates, transcripts, correspondence, and photocopied newspaper clippings.
