The files include correspondence, clippings, notes, photographs, legislative bills, minutes, press releases, and related materials documenting his service, particularly his interest in AmeriCorps' Youth Works program, parenting, housing, local performance aid, racial bias, multicultural diversity and racial fairness in the courts, and revitalization of St. Paul's Great Northern Corridor.
