SCOPE AND CONTENTS

Chronological schedule file (November 1998-December 2002), including documentation of trips to Taiwan (May 2000) and Croatia (September 2000); correspondence with educators, legislators, other states' lieutenant governors, state institutions, and constituents (1998-2002); speeches (1998-2002); files detailing Schunk's visits to a large number of Minnesota's school districts (1998-2002); and subject files (1998-2001). The latter center mainly on the lieutenant governor's interest in education, but also include files on such diverse topics as aerospace, cancer prevention, youth fitness, and her trips to Croatia and Taiwan.

RELATED MATERIALS

Schunk served as lieutenant governor under Jesse Ventura. Governor Ventura's files from this period contain additional data on many of the issues and projects found in Schunk's files.
