SCOPE AND CONTENTS

Files of James R. Gelbman, divisional coordinator for state and federal relations. The coordinator worked with the governor's Washington office to effectively present Minnesota's priorities before congressional committees and federal agencies. The records include both direct correspondence between Gelbman and Planning Agency staff, and correspondence, memos, reports, and related documents that were passed on to Gelbman for action.

Topics of particular interest include environment, health care, housing, economic development, education, agriculture, drug control, domestic and international trade, transportation, federal lobbying restrictions, and relations with the state's congressional delegations, the Council of Great Lakes Governors, and the Advisory Council on State-Local Relations. There are also files documenting the Year of the City, a 1989 proposal from Duluth, Minneapolis and St. Paul for financial and statutory assistance from the state to address problems in their core neighborhoods, and prepared booklets of federal issues with implications for the state (1990-1991).
