- Plat of Cyrus, Pope County, [ca. 1892].

Plat of lots and parks, showing individual footage measurements, of this community on the shore of Lake Minnewawa.

Shows streets, blocks, and subdivisions, occasionally with ownership notations.

Two blueprint maps of portions of Winona showing park reserves, undated.

They include geographic features, railroad lines, and owners of parcels of land.

Fountain City Bay Park and Idlewild Islands Park Preserve, Fountain City, Wis., undated.

16.5" x 52.5", rolled. Scale: 1 mile: 4". Blueprint.

Shows landholders.

Riverside Island Park Preserves, revised February 2, 1920.

16.5" x 52.5", rolled. Scale: 1 mile: 4". Blueprint.

Shows the Mississippi River islands included in the preserve, with landholders for each parcel.

Maps showing water reserve lands, undated. 3 items in folder.

Prepared under direction of Major Frederick V. Abbott, U.S.

Corps of Engineers. They show lands over which flowage rights have been ceded to the United States by the State of Minnesota in the Pokegama, Leech Lake, and Sandy Lake/Pine River reservoir basins. Blue outlines indicate approximately the extreme limits of flowage from the reservoirs, and red-bordered "forties" presumably indicate the ceded lands.

Diagram of S.W. Boundary of the Red Lake Indian Reservation through Townships 149 and 150 N R39 and part of Township 150 R40, 1894.

19" x 24". Holograph map.

Shows sections in these townships through which the boundary passes, with measurements.

Township No. 108N, Range No. 11 West of the 5th Meridian, undated.

- Pembina Trail Judicial Road: Kittson, Marshall, Pennington, Red Lake, and Polk Counties, Minnesota, undated.
23" x 150", rolled. Blueprint.
Shows route of the road, with distances for each segment.
- Township maps showing state lands, undated. 25 items in folder.
Linens.
Each quarter-quarter section of school, state institution, gov[ernment?], and vacant swamp land is marked. Acreages of land surface (as opposed to water) are often noted.
- *Township maps showing university lands, undated. 6 items in folder.
In T39 R25, T39 R26 (2 copies), and T40 R27 west of 4th Meridian; T146 R31 and T117 R31 west of 5th Meridian.
Fragile; have been backed and laminated.
- *"Minnesota State Road from Madelia to the Western Line of the State," 1863. 3 items in folder.
Scale: 2 miles: 1 in. Filed in State Land Office December 14, 1863.
Fragile; has been sectioned, backed, and laminated.
Accompanied by a volume of survey field notes, and by a line drawing that shows the townships through which the road passes.
- *"Map of Western Minnesota from Town 117 North to Sandhill River, Showing the Salt Spring and Public Building Lands as Selected by the State Commission," 1858. 2 parts in folder.
Scale: 1 in.: 6 miles.
Fragile; has been backed and laminated.
Also shows major roads, waters, and towns, and contains annotations on the nature of the land and timber in some areas.
- Plat of Climax and Vicinity, Polk County, 1900.
Accompanied by a petition from landowners for the creation of a public road.
- Ingersoll's Addition to St. Paul: Plat of Reform School Lots, 1889.
Plat showing individual lots laid out on the site of the State Reform School, accompanied by a list of the lots to be reserved from sale for the use and occupancy of the Minnesota State Reform School until its removal to the new site near Red Wing. Submitted under act of Feb. 28, 1889 [Laws 1889 c258], which authorized the platting and sale of this land for the benefit of the reform school.
Filed in the State Land Office April 5, 1889.
