

NOTES FOR NATIONALITIES SPEECH

TO: Senator Hubert H. Humphrey

FROM: David C. Williams

1. The 35 million first and second generation Americans constitute one of the sincerest and most devoted groups of citizens in the country.

2. That's why I'm proud to be a member of the Executive Committee of the Nationalities Division.

3. I commend the foreign language press, so well represented in Michigan and Wisconsin, for the attention it gives to public affairs, which compares more than favorably with the general press.

4. Our immigration policy is our front window to the world. It is wrong because:

a. It is based on the theory that people of some nationalities, some races, some religions are better than people of other nationalities, other races, other religions. It is riddled with the kind of discrimination which we condemn within America.

b. It makes immigrants and refugees into citizens with less rights than native-born citizens. There is no place in our democracy for second-class citizens.

5. I am proud that I was able to secure an additional allocation of 10 million dollars for the handling of refugees during this World Refugee Year.

6. I have repeatedly introduced immigration legislation along the lines advocated by former Senator Lehman.

7. I note the President has, on March 17, - very, very late in the day - come forward with proposals which would go part of the way in remedying the failings of present legislation. But they fall short in the following respects:

a. Racial discrimination is retained. Asiatics are still admitted on an odious racial basis.

b. The national origins quota system is retained. Place of birth is controlling, rather than the inherent worth of the individual.

c. Colonial discrimination is retained. Natives of colonial dependencies are restricted to discriminatory sub-quotas.

d. The problem of refugees is not met adequately. It permits parole of 10,000 refugees annually by the Secretary of State in the absence of a Presidential proclamation. Objections have been voiced to the 10,000 limitation and to the parole feature which keeps an alien dangling for two years or more before he can become a permanent resident.

e. The many injustices and inequities of existing immigration legislation are left unresolved. The present laws need complete and basic revisions to simplify procedures, to authorize greater flexibility, and to provide fairer standards for admitting, excluding

and deporting aliens. We can and should treat the foreign born as human beings. The present law does not do so and needs drastic revision to conform to just and humane standards and to be worthy of our great democratic traditions. The <sup>se</sup> shortcomings of our immigration laws the President's message leaves unresolved.

8. I know that all of you have keenly in mind the welfare of the people in your homelands, many of them within or under the shadow of Soviet power. We can help them in three ways:

a. Stand firm against the threat of Soviet expansion, as in Berlin. *at every Summit Conference - "The Captive Peoples!"*

b. Seek universal, effective, and enforced disarmament, so that the Soviet military power will no longer overshadow <sup>these peoples</sup> them and they will have more freedom to decide their own destinies. *(Negotiate - but know what we want!)*

c. Through works of peace, <sup>We can</sup> open windows in the Iron Curtain. One of the most imaginative of these is the American Children's Hospital in Poland, a project conceived and promoted, at great personal sacrifice, by my very good friend, the Polish-American architect, <sup>ICKI</sup> Biernacki-Poray. I was delighted to help this project in the Senate, as Congressman Zablocki did in the House.

9. We shall work in Congress for the reform of our immigration laws and for an imaginative and genuinely liberating foreign policy, But our best chance for success is in the election of a liberal Democratic President.

The Department of Health -

Education, and Welfare tells us that it costs  
at least \$2300 a year for a couple to live by  
themselves in modest fashion. Yet the average  
retired couple on social security receives  
about \$1440 a year.

Even more desperate is the situation  
of 1,300,000 aging widows ~~who are existing~~ - I  
can hardly call it living - on an average benefit  
of \$56 a month.

Yes, we need at least a 30 percent  
increase in minimum benefits, -- we need special  
housing for the elderly, -- we need tax credits  
to encourage the hiring of older workers.

But today I want to stress, to the  
ever-present dread of our older citizens - the


heartchilling fear of sickness and its  
catastrophic cost.

L I want to talk about the Humphrey  
and Forand Bills for medical benefits to the  
aged.

L I want to talk about your opportunity  
to help toward their enactment.

L This, I am reliably informed, is the  
year of a presidential election. This is the  
year when all of you who are 21 or older - and  
registered to vote - become ten feet tall to  
those who represent you or misrepresent you  
in Washington.

L There are over 13 million Americans  
who stand to benefit by the Humphrey and Forand  
Bills. Thousands have been talking and writing  
to Congress. The mail is running two to one in

favor of enactment. It's not surprising,  
therefore, that our Republican friends have  
been trying to get in on the act.

It's a tough problem for them,  
because they want to give the appearance of  
acting, without actually acting. They want  
to look good, without spending any cash money  
or offending any of the privileged minorities  
to whom they cater.

L I asked one of them once whether he really believed in progress. He claimed that he did, but cautioned that it must be very gradual.

"You mean barely <sup>noticeable</sup> perceptible" I asked him.

He seemed about to agree with me, then suddenly recoiled in horror.

L "No" he said. "That's too fast for me."

So the latest word is that the Administration is "exploring" the problem. It seems that they have only just discovered that there are nearly 16 million Americans over the age of 65, and they need time to recover from the shock.

Yes, they can't count the number of our senior citizens any more than Mrs. Oveta Culp Hobby could count the number of our children. You all remember how she complained that she just couldn't have foreseen the magnitude of the demand for the Salk anti-polio vaccine.

Mrs. Hobby has departed, but a lot of hobbyists remain in Washington. They are still concerned, like her, with balancing the fiscal budget rather than the moral budget.

All I say is - let them not practice this hobby at our expense.

Let's get back to this word "exploring". This Administration often reminds me of Christopher Columbus - when he set out he didn't know where he was going,

when he got there he didn't know where he was, and when he returned he didn't know where he had been.

However, this time I believe that the Administration knows what its "exploring" for. And I can tell you that it's not looking for the best and the soundest means of meeting the medical needs of our elder citizens.

It's playing politics, and "exploring" for votes.

It's seeking the maximum political benefits to Mr. Nixon, rather than the maximum medical benefits for you.

It's seeking the most plausible way of stalling, rather than the promptest way of acting.

Yes, my friends, it's all politics -- cold-blooded, Old Guard Republican politics, rather than warm-blooded concern for people

and their problems.

Don't let them get away with it.

Let's all of us, today, resolve

to insist on the genuine and sincere Forand

and Humphrey program. Don't let some Doctor-

come-lately substitute be palmed off on us

by that master of political now-you-see-it

and-now-you-don't Vice President Nixon.

Keep on writing to Washington, my

friends. Don't let the Administration side-

track our bills at the very brink of a his-

retired Americans have placed it.

Keep up the pressure in the coming weeks and months. And if they are still in this fix by November, you know how you can get them out of it. You can elect a liberal Democrat -- I have my own private preference, and I hope and trust it is the same as yours -- to the White House.
