WADENA, Sept. 7 -- At long last the nation is awakening to the opportunities for using America's food abundance as an effective force for peace, Senator Hubert H. Humphrey declared at a luncheon here today.

"For the last four years we have led the fight for an effective Food for Peace program -- and for our country taking the initiative in the United Nations toward mobilizing the excess food supplies of the surplus-producing countries for the benefit of all humanity," Senator Humphrey said.

"Each year we have met with stubborn foot-dragging and opposition of a reluctant Republican administration that seemed willing to cry about surplus problems but unwilling to use some imagination in finding constructive uses for our abundance.

"The American people once again led the way, and are compelling even Republicans to turn about-face on the Food for Peace issue. It just didn't make sense to the American people to lock up hugh surpluses at taxpayers' expense --and to compel farmers to stop producing -- when hungry people in the world were seething in near-revolt. But it did make sense to most Americans to look for ways to use our abundance, not only to feed the hungry but to finance economic development in underdeveloped areas of the world.

"We have pioneered the way to do it under Public Law 480, despite stubborn opposition. We have proven it works. Now our fight is to convince reluctant Republicans to be a bit more bold and more daring in a realistic war against hunger in the world," Senator Humphrey said.

Senator Humphrey, originator of the Food for Peace program in Congress, was successful in getting the Senate to adopt a resolution calling upon the President to negotiate through the United Nations for an effective international program aimed at eliminating hunger and suffering and helping with economic development through use of excess food production from this and other surplus-producing countries.

"I am convinced that under a new Democratic administration, our nation will take the lead in an aggressive war against hunger everywhere -- living up to our heritage as humanitarians and opening vast new outlets for American farm products," Senator Humphrey declared.
