Life has many blessings. Few are more precious than good health.

We seek good health for ourselves and for our family.

But as we grow older, illness strikes more often. Persons over 65 require <u>three times</u> more hospitalization than younger Americans.

With sickness come pain and suffering and <u>medical</u> bills -- often very big bills.

One sickness can wipe out the savings a family has accumulated in a lifetime, and this tragedy has overtaken thousands of American families. To meet this great National problem, President Johnson has proposed an historic bill -- a humanitarian bill. It is popularly known as <u>Medicare</u>.

Medicare has already passed the House of Representatives -- by a very sizeable vote. The Bill is now under consideration in the U. S. Senate.

The Bill makes possible many important health benefits. Most of the provisions are overwhelmingly endorsed by all segments of American society, including doctors, nurses, and other members of the healing arts.

The "heart" of the Bill provides basic protection for hospital care.

This protection would be paid for by the <u>pay-as-you-go</u> principle. Each of us would contribute from our paycheck a small amount, so that later on, when we

retire, hospital costs would be automatically covered.

Herewith text of Vice President's talk in ABC Television Network program "MEDICARE THE AMERICAN WAY" -- produced by the National Council of Senior Citizens, 1627 K St., N.W. on June 18, 1965. Medical science has advanced more rapidly in our lifetime than in all of previous history. But unfortunately not all patients have uniformly benefitted -- especially the poor, the elderly poor. And many Senior Citizens even in middle income brackets have not uniformly benefitted either. Medicare will, therefore, help bring the miracles of medical science to Americans who too often have been <u>bypassed</u> because of financial limitations.

We are counting on our doctors to help make it work.
