THE HONORABLE HUBERT H. HUMPHREY
DULUTH DAY
DULUTH, MINNESOTA
MAY 22, 1969

I WANT TO SPEAK BRIEFLY OF THE WORLD SITUATION
TODAY AND THEN I WOULD WELCOME YOUR QUESTIONS.

✓ FIRST, IT IS INCREASINGLY EVIDENT THAT THE
WORLD TODAY IS PASSING THROUGH AN AGE OF TRANSITION.

✓ AS HENRY KISSINGER SAID RECENTLY, "TO A DEGREE
RARE IN HISTORY, WORLD LEADERS ARE MOVING INTO A
GREAT UNKNOWN. ✓ RULES FOR WORLD ORDER, WRITTEN LESS
THAN 25 YEARS AGO, ARE ALREADY WEARING OUT. ✓ NEW
WAYS FOR COUNTRIES TO DEAL WITH EACH OTHER WILL
HAVE TO BE FOUND."

✓ THIS TRANSITION HAS MANY ASPECTS, OF WHICH THE
SOCIAL AND CULTURAL MAY BE THE MOST IMPORTANT.

L BUT IT ALSO HAS A POLITICAL DIMENSION. L IT REFLECTS
THE BREAKUP OF A WORLD ORDER IN WHICH THE NATURE OF
POWER AND AUTHORITY HAS SEEMED REASONABLY CLEAR.

L OLD NATIONAL ALLIANCES, SUCH AS THE SPECIAL AND
UNIQUE RELATIONSHIP BETWEEN THE U. S. AND GREAT BRITAIN
ARE CHANGING. L NEW FORCES, SUCH AS JAPAN, WHICH IS
ALREADY THE THIRD STRONGEST ECONOMIC POWER IN THE
WORLD ARE EMERGING.

L IN ADDITION, IT IS NOW CLEAR THAT MANY OF THE
PROBLEMS CONFRONTING THE NATIONS OF THE WORLD WILL
NO LONGER YIELD TO THE POWERS THROUGH WHICH THE WILL
OF GOVERNMENTS HISTORICALLY HAVE PREVAILED. *namely the*
SWORD AND THE PUBLIC PURSE.

L LET ME BE MORE SPECIFIC. IN 1832 KARL VON CLAUSEWITZ
LAID DOWN THE DICTUM THAT "WAR IS NOT MERELY A POLITICAL
ACT, BUT ALSO A POLITICAL INSTRUMENT. A CONTINUATION
OF POLITICAL RELATIONS. A CARRYING OUT OF THE SAME
BY OTHER MEANS."

BUT TODAY, GIVEN THE UNPRECEDENTED POSSIBILITIES THAT NATIONS NOW HAVE FOR DEVASTATING THEIR OPPONENTS, WAR CAN NO LONGER BE CONSIDERED AS MERELY AN EXTENSION OF POLITICS. (THE COSTS FOR ALL SIDES ARE JUST TOO GREAT,

IN ADDITION, "CONVENTIONAL" WARFARE SEEMS, IN MANY CASES, TO BE MISSING AN INGREDIENT THAT WAS VITAL TO VON CLAUSEWITZ'S RULE: THE CAPACITY FOR RUTHLESSNESS.

AS STEWART ALSOP POINTED OUT RECENTLY, MILITARY POWER IS A DECISIVE MILITARY INSTRUMENT ONLY IF THE VICTOR CARRIES OUT ITS MILITARY VICTORY WITH SUFFICIENT RUTHLESSNESS SO AS TO LAY THE ISSUE TO REST FOR SOME PERIOD OF TIME.

IN THREE RECENT MILITARY CONFRONTATIONS, NATIONS OF THE WORLD HAVE NOT SO CARRIED OUT THEIR EFFORTS: THE ARAB-ISRAELI WAR, THE U. S. IN VIETNAM, AND THE RUSSIAN-CZECHOSLOVAKIA AFFAIR.

IN SHORT, VON CLAUSEWITZ'S OLD DICTUM NO LONGER WORKS VERY WELL IN 1969. THE POWER OF GOVERNMENTS TO STRUCTURE OTHERS BY MILITARY FORCE HAS CHANGED IN ITS SCOPE AND CHARACTER.

AT THE SAME TIME, THERE IS A DEVELOPING AWARENESS THAT ACTION BY EVEN THE MOST WEALTHY GOVERNMENTS CANNOT MOBILIZE THE EXTERNAL RESOURCES NEEDED TO SOLVE THE PROBLEMS FACED HERE AND ABROAD.

THUS, TRADITIONAL NOTIONS OF THE POWER AND AUTHORITY OF NATIONAL GOVERNMENTS NO LONGER COMMAND THE ALLEGIANCE THEY ONCE DID. PEOPLE AND NATIONS ARE GROPPING FOR NEW CONCEPTS WHICH WILL RESPOND MORE DIRECTLY TO THE NEEDS OF TODAY. THE FAILURE TO FIND THEM AS YET ACCOUNTS FOR SOME OF THE UNEASE AND QUESTIONING WHICH CHARACTERIZES MUCH OF TODAY'S WORLD.

A SECOND FEATURE OF THE "WORLD TODAY" IS THAT WE ARE WITNESSING THE GROWTH OF A NEW SET OF DIVISIONS IN THE WORLD -- DIVISIONS THAT RIVAL AND THREATEN TO OUTSTRIP THE TRADITIONAL EAST-WEST CONFRONTATION.

THESE DIVISIONS ARE BETWEEN THE NORTHERN AND SOUTHERN PARTS OF THE WORLD -- BETWEEN THE RICH AND THE POOR, WHITE AND COLORED, STABLE AND UNSTABLE. THEY ARE INTENSIFIED BY THE CLOSE ASSOCIATION BETWEEN POLITICAL CONTROL AND RESOURCES.

THE PEOPLE AND NATIONS IN THE SOUTHERN PART OF THE WORLD NEED ACCESS TO TECHNOLOGY AND WEALTH BUT THEY ALSO NEED TO CONTROL THEIR OWN LIVES. MOST RESOURCES, HOWEVER, ARE CONCENTRATED IN THE HANDS OF THE NORTH, IN WHITE AMERICA, AND IN THE RICH, INDUSTRIALIZED NATIONS -- AND THESE NATIONS HAVE TENDED TO MAKE THEM AVAILABLE ONLY ON THEIR OWN TERMS.

THE SOUTHERN PART OF THE WORLD, THEN, IS LEFT WITH THE CHOICE OF SELF-DETERMINATION WITH FEW RESOURCES, AND MORE RESOURCES WITH LITTLE SELF-DETERMINATION. THESE DIVISIONS AND THESE PROBLEMS PRESENT A PARTICULAR DIFFICULTY TO AMERICA.

WHILE THE DEVELOPING COUNTRIES ARE TOO WEAK TO DO US PHYSICAL HARM, OUR MORAL VALUES COULD BE ERODED IF WE STOOD BY PASSIVELY IN THE FACE OF DEEPENING HOSTILITY AND HUMAN MISERY ABROAD. LIKE THE TRADITIONAL RICH LANDLORD, WE COULD WIND UP BEING CORRUPTED BY OUR ISOLATION FROM THOSE ABOUT US.

DESPITE THE EMERGENCE OF THIS NEW INTERNATIONAL DIVISION, THE EAST-WEST, OR MORE SPECIFICALLY, THE U. S. - SOVIET RIVALRY CONTINUES TO BE THE DOMINANT CHARACTERISTIC OF THE WORLD TODAY.

THIS RELATIONSHIP CONTINUES TO BE A MIXTURE OF BOTH COOPERATION AND CONFLICT AND ONE WHOSE CONTOURS ARE CONSTANTLY CHANGING. THE SOVIETS, PARTICULARLY, SEEM TO BE ENTERING A NEW PHASE IN THEIR EVALUATION OF THIS RELATIONSHIP.

SPEAKING TO THE AMERICAN FOREIGN SERVICE ASSOCIATION LAST NOVEMBER, PROFESSOR ZBIGNIEW BRZEZINSKI, A FORMER MEMBER OF THE POLICY PLANNING COUNCIL OF THE DEPARTMENT OF STATE, ARGUED THAT THE SOVIET LEADERSHIP IN RECENT YEARS HAS REASSESSED THE SCALE, THE SCOPE AND THE CHARACTER OF PEACEFUL CO-EXISTENCE, HAS CONCLUDED THAT PEACEFUL CO-EXISTENCE WHERE BOTH SIDES PLAY EVENLY IS MORE DANGEROUS TO THEIR STABILITY THAN TO OUR OWN AND HAS BEGUN TO LIMIT EAST-WEST TIES.

WHEREAS THE "OLD" PEACEFUL CO-EXISTENCE WAS AN OPEN-ENDED GAME IN WHICH WE WOULD TRY TO IMPROVE RELATIONS WITH THE EAST EUROPEANS AND THE SOVIET UNION WOULD FLIRT WITH WEST EUROPEANS, THE NEW, "LIMITED CO-EXISTENCE" ALLOWS SPECIFIC ARRANGEMENTS IN SENSITIVE AND MUTUALLY NECESSARY AREAS SUCH AS ARMS CONTROL BUT PROHIBITS THE BROAD FRATERNIZATION INTO WHICH MR. KHRUSHCHEV WAS PREPARED TO PLUNGE. BECAUSE OF THIS, COMPETITION WILL REMAIN THE CENTRAL CHARACTERISTIC OF THE U. S. - SOVIET RELATIONSHIP, BUT WILL NOT PRECLUDE SPECIFIC, LIMITED ARRANGEMENTS.


A FOURTH CHARACTERISTIC OF THE CONTEMPORARY WORLD SITUATION IS THAT THE TIES BETWEEN THE AVERAGE MAN AND THE MAN IN GOVERNMENT ARE EVERYWHERE BREAKING DOWN.

THERE IS AN INCREASING SENSE OF ALIENATION ABROAD, PARTICULARLY IN THE INDUSTRIALIZED NATIONS OF THE WORLD. IN THE SOVIET UNION, IN THE U. S., IN MEXICO AND IN FRANCE YOUTH IS DISSATISFIED WITH THE OBJECTIVES AND THE PROCEDURES OF THEIR GOVERNMENTS AND PRESS DEMANDS FOR POLITICAL REFORM.

DISILLUSIONMENT WITH PARLIAMENTARY GOVERNMENT IS WIDESPREAD IN WESTERN EUROPE AND FAITH IN THE LEGISLATIVE PROCESS CANNOT BE SAID TO BE VERY HIGH IN THIS COUNTRY. INDEED, THE HONESTY OF GOVERNMENT ITSELF IS WIDELY IN QUESTION.

THE EVIDENCE FROM COMMUNIST NATIONS SUGGESTS THAT OFFICIAL CORRUPTION IN ALL ITS FORMS, FROM OUTRIGHT THEFT TO THE PEDDLING OF INFLUENCE AND THE MORE SHADOWY AREA OF NEPOTISM, IS A CONTINUAL IRRITANT TO THE POPULATION.

IN SEVERAL COUNTRIES, RUSSIA, CANADA, THE U. S.,
RACIAL AND ETHNIC TENSIONS CONTRIBUTE TO THIS FEELING
OF ALIENATION AND LEAD MANY TO THE POSITION THAT
EXISTING POLITICAL INSTITUTIONS MUST BE RADICALLY
CHANGED.


IN SHORT, THE FERMENT WHICH WE WITNESS IN THIS
COUNTRY IS A WORLD-WIDE PHENOMENON -- LIMITED TO NO
SINGLE COUNTRY, ECONOMIC SYSTEM OR IDEOLOGY.

WE LIVE IN DIFFICULT, CHALLENGING, YET
TREMENDOUSLY EXCITING TIMES.

I BELIEVE THAT THE UNITED STATES HAS A SPECIAL
ROLE TO PLAY IN THE WORLD TODAY AS I HAVE DESCRIBED
IT.

WE MUST CONTINUE TO TAKE AN ACTIVE PART IN
DEVELOPING THE WORLD TOWARD A RICHER AND MORE
REWARDING PLACE FOR ALL HUMAN BEINGS.

THIS DOES NOT REQUIRE US TO BE THE "POLICEMAN
OF THE WORLD," RESPONDING TOO QUICKLY, TOO AUTOMATICALLY,
AND TOO UNTHINKINGLY TO EVERY SITUATION. NEVERTHELESS,
WE CANNOT WITHDRAW WITH IMPUNITY FROM A WORLD THAT
CRIES OUT FOR LEADERSHIP AND DIRECTION.

WE MUST SEEK, IN COOPERATION WITH OTHERS, TO
PROVIDE THAT LEADERSHIP.

THERE ARE MANY OTHER SPECIFIC PROGRAMS AND
POLICIES I WOULD ADVOCATE FOR THIS NATION. I TALKED
ABOUT MANY OF THEM IN THE PRESIDENTIAL CAMPAIGN.

BUT RATHER THAN TALK ABOUT THEM IN MY INTRODUCTORY
REMARKS, I SUGGEST WE MOVE NOW TO QUESTIONS, AND I
WILL AMPLIFY MY THOUGHTS FURTHER AS WE GO ALONG.

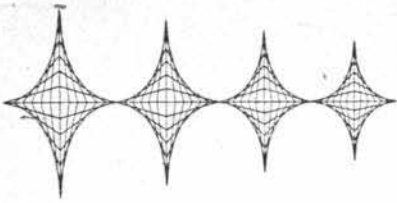

Dear Mr. Humphrey:

We are extremely pleased to learn of your acceptance to speak at the Duluth Day Dinner on the evening of May 22 at the Duluth Arena.

Please consider this a formal invitation to fill this speaking engagement. We understand your honorarium will be \$750.00 with an additional \$250.00 for Mrs. Humphrey to speak at the women's luncheon at noon on the 22nd.

This will be the 51st annual Duluth Day Dinner. An attendance of about 2,000 men is anticipated, half of them from nearly 200 communities in Minnesota, northern Wisconsin, the upper peninsula of Michigan and Canada. Out of town businessmen are guests of Duluth-based firms for the dinner.

The program will get underway with a social hour at 5:30. At 6:15 the dinner will be served with the formal program to start about 7:30. You will be interested to know that your old friend Tom Bell has agreed to serve as master of ceremonies. Jeno Paulucci will introduce you.

We plan to set up a news conference at 4:00 p.m. for you and Mrs. Humphrey at the Hotel Duluth, after which you will be driven to the Arena. Arrangements will be made for a group of local ladies to take Mrs. Humphrey out to dinner and spend the evening.

The Duluth Chamber of Commerce has asked Jenö to contact you to extend an invitation to you to be the speaker at this year's Duluth Day Dinner. 

Dear Dave:

Nice talking to you on the telephone today. As I mentioned to you, Jeno Paulucci and myself had a nice meeting with HHH on Monday, April 14. He wanted me to get in touch with you on the following items (items discussed on the telephone today with you).

1. Duluth Day Dinner

You indicated HHH has a teaching schedule and thus could not arrive in Duluth until approximately 5:00 p.m. . . . eliminating the possibility of his attending the Press Club luncheon proposed.

The schedule then on May 22 for the Duluth Day Dinner should look something like this:

Press Conference (Hotel Duluth) - 5:00 p.m.
Duluth Day Dinner Social Hour - 5:30 p.m.
Duluth Day Dinner - 6:15 p.m.
Duluth Day Program - 7:30 p.m.
Reception for HHH and Muriel (Paulucci Hall) - 8:30 p.m.

Jeno Paulucci will introduce HHH and Tom Ball will serve as master of ceremonies.

You advised if there is a change in the teaching schedule at the U of M, HHH would let us know about reinstating the Press Club luncheon at 12:00 Noon on May 22 (otherwise you suggest perhaps a press breakfast on Friday, May 23 . . . at approximately 8:00 or 8:30 a.m., if agreeable with Jim Oberstar.)

Will keep in touch with you as plans develop further for this Duluth Day Dinner.

2. Transportation - May 22, 23, 24

You indicated you had written Jenö with respect to possible use of his airplane for HHH from Minneapolis to Duluth May 22; Duluth to Iron Range May 23; and Iron Range to Minneapolis May 24.

Will advise you on this shortly.

3. Enclosed are some copies of Jenö's proposal on a "New Cities Program" as proposed in an open letter to be run in the nation's leading newspapers shortly. HHH indicated you would call this open letter to the attention of both Sig Mikkelson and Harry Reasoner at CBS . . . with the idea being that it would be good if Jenö was invited to appear on the CBS "60-Minutes" with Harry Reasoner. Would appreciate your following up on this at once to see if there is any interest on CBS' and Harry Reasoner's part for Jenö to be on the program to discuss this new cities idea.

We have a tape on the "New Cities concept" made at a TV station in Florida that Harry Reasoner and his program people might want to review. We will be glad to forward it to them to further advise them of the nature of the program.

4. HHH indicated I should request from you a copy of a speech titled "The New City" (?) he made in California. He thought it was in Los Angeles. Would you please send me a copy of this speech?
5. HHH has asked us to send a suggested column for his use in the new newspaper column he is writing. This will be in the mail to you this week. HHH expressed a great interest in Jenö's "New Cities" proposal and a column on this subject should prove to be most fruitful.
6. HHH indicated Mrs. Humphrey's "beef soup" is out of this world! Please arrange for a recipe to be sent us.
