I'M TALKING TO THE PEOPLE WHO MAKE VICTORY POSSIBLE FOR OUR DEMOCRATIC PARTY --HARD-WORKING, LOYAL DEMOCRATS. AND I AM ESPECIALLY PLEASED TO JOIN WITH YOU IN HONORING AN INDIVIDUAL WHO HAS CONTRIBUTED MUCH TO THE DEMOCRATIC PARTY. While addressing a luncheon of Democratic women during THE 1960 CAMPAIGN, PRESIDENTIAL CANDIDATE JOHN F. KENNEDY JOKED SAYING, "I BELIEVE THE DEMOCRATIC PARTY CAN DO THE JOB BEST, AND I COME AND ASK YOUR HELP IN DOING IT. THERE'S AN OLD SAYING -- 'NEVER SEND A BOY TO DO A MAN'S JOB -- SEND A LADY'."

SHE SERVED THE STATE IN THIS CAPACITY UNTIL 1966. BUT, MEANWHILE BACK IN MOWER COUNTY, STELLA SERVED ON THE MOWER COUNTY WELFARE BOARD FROM 1958 TO 1966. SHE HAS CONTINUED HER MOWER COUNTY CIVIC SERVICE AND IS PRESENTLY SERVING ON THE MOWER COUNTY ZONING COMMISSION OF WHICH SHE HAS BEEN A MEMBER SINCE 1967,

IN ADDITION, STELLA IS ALSO PRESENTLY SERVING AS A MEMBER OF THE BOARD OF THE AUSTIN ACTIVITY CENTER FOR RETARDED CHILDREN. AT THIS POINT, I SIMPLY MUST ADD SOME PERSONAL WORDS OF APPRECIATION TO STELLA. MANY OF YOU KNOW THAT MURIEL AND I HAVE A VERY SPECIAL INTEREST IN HELPING RETARDED CHILDREN. WE KNOW THE HOPE AND SATISFACTION OF HELPING HANDICAPPED CHILDREN GROW AND LEARN; WE KNOW THE JOY IN HELPING THESE SPECIAL CHILDREN LOVE AND BE LOVED AND WE ALSO KNOW THE FRUSTRATION AND DISAPPOINTMENT WITH LIMITATION OF RESOURCES - FINANCIAL AND HUMAN -- THAT ARE DIRECTED TO THIS AREA OF CONCERN. WE, THE FAMILIES OF THESE CHILDREN, AND OTHER INTERESTED CITIZENS APPRECIATE STELLA'S SINCERE CONCERN FOR CHILDREN.

CHILDREN NEED STRENGTH TO LEAN ON A SHOULDER TO CRY ON AND AN EXAMPLE TO LEARN FROM STELLA JENSEN HAS UNSELFISHLY PROVIDED AN EXCELLENT EXAMPLE. A M SURE THAT STELLA'S DAUGHTER, MRS. MCCRORY OF SOUTH BEND, INDIANA, WHO IS WITH US TONIGHT -- WELCOME TO MINNESOTA -- TREASURES HER MOTHER'S FINE EXAMPLE.

DURING YOUR CAREER AS A DFL PARTY OFFICER, I HAVE BEEN A SENATOR, VICE PRESIDENT, AND PRESIDENTIAL CANDIDATE, AS AN OFFICE HOLDER AND A CANDIDATE, I HAVE NEEDED THE ASSISTANCE AND LOYALTY OF GOOD, DEDICATED DFLERS, YOU, STELLA, HAVE BEEN A DEAR AND CHERISHED FRIEND. AND, STELLA, I REMEMBER ALSO THAT YOU ATTENDED THE 1964 INAUGURATION, AND I'M SURE THAT YOU WON'T MIND MY TELLING ABOUT AN INCIDENT -- THE LIGHTER SIDE OF POLITICS --WHICH OCCURED ON YOUR TRIP TO WASHINGTON, IT SEEMS, MY FRIENDS, THAT FOLLOWING THE INAUGURATION, THE JOHN PILLSBURYS HAD A LOVELY RECEPTION AT THE WASHINGTON STATLER HOTEL FOR THE MINNESOTA PEOPLE IN ATTENDANCE, WHEN STELLA ARRIVED AT THE BEAUTIFULLY APPOINTED SUITE SO GRACIOUSLY BEING HOSTED BY

MR. PILLSBURY, THE PEOPLE IN ATTENDANCE WERE RATHER SUBDUED AND THERE WASN'T MUCH CONVERSATION IN PROGRESS, AS MR. PILLSBURY GREETED HER, STELLA, IN HER USUAL EFFUSIVE MANNER, SAID IN A RATHER LOUD VOICE, "How IS BETTY CROCKER?" -- TO WHICH MR. PILLSBURY REPLIED, "WE MUST HAVE A PRACTICAL JOKER HERE." STELLA, STILL INNOCENTLY WANTING TO MAKE CONVERSATION REPEATED, "No. I REALLY MEAN IT -- HOW IS BETTY CROCKER?" FINALLY, SOMEONE POINTED OUT THAT BETTY CROCKER ADVERTISED GENERAL MILLS PRODUCTS AND NOT PILLSBURY PRODUCTS, MUCH TO STELLA'S CHAGRIN AND AMUSEMENT,

WE HAVE TALKED TONIGHT OF HONORING STELLA AND OF THANKING HER. WE ARE HAPPY TO PARTICIPATE IN OCCASIONS SUCH AS THIS, AND THESE OCCASIONS BECOME HAPPY MEMORIES. BUT WHAT A GREAT THING IT WOULD BE IF WE COULD DEDICATE OURSELVES TO AN <u>ON-GOING TRIBUTE</u> TO STELLA AND TO ALL THOSE LIKE HER WHO HAVE AND WILL BE THE LIFEBLOOD OF OUR PARTY. The essence of politics is to translate the concerns and the creative responses of a vast citizenry into effective and humane laws, We can dedicate ourselves to a politics which dwells on peace, progress, and people. We know and are dissatisfied with the state of the country and with some of the conditions in our state of Minnesota, We know that our country and our state face crises that demand action. But we also know that, in America, governments do not fall in times of crises; they linger on till the first Tuesday after the first Monday of November. We can dedicate ourselves in 1972 to electing people committed to these goals — Peace, progress, people.

We, as MINNESOTA DEMOCRATS, HAVE AN OPPORTUNITY TO INFLUENCE NATIONAL AND INTERNATIONAL POLICY BY HELPING TO ELECT A DEMOCRATIC PRESIDENT -- A PRESIDENT WHO WILL TRULY BE THE PEOPLE'S LOBBYIST -- AND BY RETURNING OUR FINE SENIOR SENATOR WALTER MONDALE TO THE U. IN 1970, THIS DEDICATION RESULTED IN THE GREATEST LEGISLATIVE GAINS IN ANY ONE YEAR BY EITHER PARTY IN THE STATE'S HISTORY. IN ADDITION, THIS DEDICATION RESULTED IN MY RETURNING TO THE SENATE WITH THE GREATEST MARGIN OF MY CAREER.

UNITY DOES MEAN THAT WE WORK TOGETHER TO ACTIVATE ALL DFLERS; TO IDENTIFY UNREGISTERED VOTERS AND TO RECRUIT NEW DFLERS; TO STAFF AND WAGE EFFECTIVE CAMPAIGNS. WE MUST INCLUDE ALL PEOPLE -- BLACK AND WHITE, RICH AND POOR, OLD AND YOUNG. WE NEED IN THE DEMOCRATIC PARTY THE WISDOM OF EXPERIENCE. BUT WE MUST NOT LET OUR PARTY GROW OLD IN SPIRIT!
