

REMARKS BY SENATOR HUBERT H. HUMPHREY

NATIONAL FARMERS ORGANIZATION

Kansas City, Missouri
December 16, 1971

I regret that I cannot bring you good tidings from Washington about Senate passage of the Strategic Reserve Bill.

This bill, as you know, would authorize national reserve inventories and direct increases in the loan rate for wheat and feed grains in 1971 and 1972.

The Senate's failure to complete action on this legislation is regrettable. Among other things, it will likely kill any chance of affecting the 1971 loan rates for wheat and feed grains, which would deny millions of dollars in additional income to producers of these crops.

I will continue my fight for passage of this bill -- already approved by the House -- as well as my resolution requiring adjustments in the 1972 wheat and feed grain programs. But it is clear that we can expect some strong opposition to these measures when Congress reconvenes next year.

There are too many people and interests in this nation today who benefit from low prices for our farm products. But, if the consumers of this country don't wake up soon to the fact that continued low farm prices mean the eventual destruction of our nation's family farm enterprise system, they will soon be forced to spend much more of their disposable income for food, instead of the 17 percent they now spend.

If farmers were rewarded or compensated for their investment and labors based on what the President and all the economists say should be our ruling guide for prices and wages, namely productivity, farmers should be getting:

- \$5 per bushel for their wheat
- \$3 per bushel for their corn
- \$50 per hundred for their cattle.

The productivity rate of the farm sector of our economy today is twice that of the nonfarm sector. Yet farmers continue to be penalized rather than rewarded for their efforts.

As a nation, we are quick to come to the aid of our railroads, our aircraft industry or other depressed industries, but we fail to respond to the depressed income needs of millions of farm families.

You and your leadership, especially Oren Lee Staley, have been in the forefront of this battle to secure economic justice for our farm producers.

Your self-help efforts in the field of farm bargaining have been unparalleled in farm history.

But you also need and deserve help from your national government to further strengthen those efforts. And I intend to continue my efforts to help you get that needed assistance.

During the Senate hearings and debate on the confirmation of Dr. Butz as Secretary of Agriculture, you and your leaders were there helping us dramatize the legitimate needs of family farmers.

And as I said just before the Senate vote on Dr. Butz's confirmation, "This debate will hopefully mean at least another \$1 billion in farm income next year."

I hoped the debate might have some import on the President. But that remains to be seen, and the record so far has been dismal.

Although Secretary Butz was given permission to buy some corn, purchases to date have been so small that market prices have moved little from what they were previously.

And, frankly, I believe that what small gains have been made have been made as a result of the House's action on the Strategic Reserve Bill rather than any USDA corn buys.

The grain trade knows the difference between USDA press releases about planned corn purchases and a bill that would require the purchase of 25 million tons of feed grains, 300 million tons of wheat and increase the loan rates for both commodities this year and next.

Yes, 1972 will be a year of decision for American agriculture and our nation's family farm producers -- and for the Administration.

When we return to Washington next January, we must complete action on several pieces of legislation important to the future of agriculture: They include:

- The Strategic Storable Agricultural Commodities Bill
- Legislation I have introduced to adjust the 1972 wheat and feed grain programs to insure that production will be brought in line with utilization demands
- Meaningful farm bargaining legislation
- Legislation to help meet the basic income and special assistance needs of smaller farmers, and
- Legislation to protect the family farmer from unwarranted incursions by corporate agriculture.

Realized net farm income this year is expected to drop by about \$300 to \$500 million. And, unless something is done about our grain surpluses and about cutting back production of wheat and feed grains in 1972, further drops in farm income can be expected again next year.

Next year is also going to be a Presidential election year when American farmers and rural people should press their case for better income opportunities.

During the 1968 Presidential campaign, Mr. Nixon made a number of promises about improving farm income and strengthening the voice of farm and rural America. But let us take a quick look at what has happened since he became President:

- Farm prices are the lowest they have been in the past twenty-three years for some commodities
- Parity is down to 70 percent
- Net farm income has drifted downward
- Acreage set-aside programs have been substituted for sound supply-management programs
- Huge surpluses of wheat and feed grains are now hanging over the market, thereby depressing prices
- The President has recommended the near abolition of USDA, and a number of programs serving rural people through his rural revenue sharing proposal
- He has impounded millions of dollars in desperately needed REA, ACP, Food Stamp, and other USDA program funds and
- He has appointed a man as Secretary of Agriculture who enjoys little or no support from the farm people he should be representing.

Do you want four more years of that kind of performance?

Neither farmers nor those who depend upon farmers for income or profits can afford another four years of such continued treatment.

American farmers must pull together in the next few years like they have never done before. Unless they unite their potential political strength, they will continue to be ignored and shunted aside by their national government and political leaders.

I pledge you my support in Congress.

We cannot -- and must not -- permit the destruction of our nation's family farm system.
