HUMPHREY ACCUSES ADMINISTRATION OF
BLIND INDIFFERENCE TO POOR AND URBAN
AMERICANS

TAMPA, March 9--Senator Hubert H. Humphrey today accused the Nixon Administration of "callous cutbacks, broken promises, and blind indifference to the American poor and the city dweller after a decade of progress under Democratic administrations."

In an address to the Conference of the Florida Association of Community Action Agencies here, Humphrey said:

"The position of the Nixon Administration is simply this: If it's for the cities or if it's for the poor, cut it out. And the budget of the Administration proves it. The President's message to the poor is 'wait--wait a little longer.

"In housing and community development, the Nixon Administration would spend \$1.3 billion less than Congress appropriated last year.

"That means \$465 million less for rebuilding our cities. It means no increase at all in the Model Cities program. It means cutting rent supplements and rental assistance.

"It means new construction starts in public housing will fall way below national goals.

"And in human terms, it means that too many people will continue to live in dilapidated housing, shabby, unhealthy apartments, rundown neighborhoods in deteriorating inner cities."

Humphrey said the Administration is in full-scale retreat in the anti-poverty program with a proposal to cut \$140 million.

"It plans no expansion of the food stamp program. It plans to slash the Community Action Program--your program--by \$56 million.

"And they've tried before, and they'll try again to eliminate the emergency food and medical service program.

"These budget cuts are callous, restrictive, and punitive. They show nothing but blind indifference to the needs of the poor."

Humphrey said that after a steady decline in the number of Americans living in poverty under Democratic Administrations, the number rose last year for the first time in a decade.

"In the 1960s, we began a food stamp program that has gone from 100,000 participants to over 10 million," he said.

"We began Medicaid so that those who have less can have decent health care.

"We began the Neighborhood Youth Corps so that the sons and daughters of the poor could participate in worthwhile work.

"We began Headstart and the Job Corps and legal services and community action agencies.

"The time has come to renew that commitment to end poverty and hunger in America.

"The time has come for President to pledge that he will undertake that task. Until we have new leadership, we will remain a Nation of 25 million Americans, ill-fed, ill-housed, ill-clothed and ill-cared for."

THESE PROGRAMS ARE NOT DREAMS, THEY'RE NOT PLANS ON PAPER. THEY'RE HERE, THEY'RE REAL. AND THEY MUST BE CONTINUED AND STRENGTHENED.

THERE WAS ANOTHER SIDE TO OUR ANTI-POVERTY EFFORTS OF THE 1960'S. IT WAS A BELIEF THAT SOMETHING COULD BE DONE. IT WAS A BELIEF THAT HERE IN THE NEIGHBORHOODS, WHAT ONE PERSON DID, MADE A DIFFERENCE.

AND THESE BELIEFS WERE ECHOED AT THE HIGHEST LEVELS OF GOVERNMENT. PRESIDENT KENNEDY AND PRESIDENT JOHNSON HAD A BELIEF IN PEOPLE AND WERE COMMITTED TO AIDING THE POOR IN AMERICA.

AS WE BEGIN A NEW DECADE I SENSE A LESSENING IN OUR STRUGGLE TO AID THE POOR, A SLACKING OF THE PACE TO END HUNGER. IT'S ALMOST AS IF THE WILL HAS GONE OUT OF OUR FIGHT IN THE BATTLE AGAINST POVERTY.

AND THE AMERICAN PEOPLE ARE NOT TO BLAME FOR THEY STILL HAVE THE COMPASSION AND SENSITIVITY TO CARE.

BUT THE NIXON ADMINISTRATION WITH ITS CUTBACKS AND BROKEN PROMISES HAS FAILED TIME AND TIME AGAIN TO EQUAL THE PEOPLE'S COMPASSION AND SENSITIVITY TO THE NEEDS OF THE POOR.
