

WE CANNOT LET OUR 18 YEAR EFFORT TO END THIS WRONG BE TURNED BACK. ARE WE GOING TO SAY THAT THIS NATION IS COMMITTED TO A SCHOOL SYSTEM THAT IS SEPARATE AND UNEQUAL.

ARE WE GOING TO PUT THE CONSTITUTION INTO A DEEP FREEZE AS THE PRESIDENT SUGGESTS.

I PLEDGE TO YOU TODAY, I WILL NOT LET RICHARD NIXON LEAD THIS NATION BACKWARD.

I BELIEVE THERE ARE NEW DIRECTIONS FOR US TO FOLLOW OTHER THAN THE PRESIDENT'S PATH BACKWARDS.

WE MUST HAVE THE FEDERAL GOVERNMENT FINANCE AT LEAST ONE THIRD OF EDUCATION COSTS SO THAT ALL OF OUR SCHOOLS AND NEIGHBORHOODS ARE IMMEDIATELY UPGRADED. AND WE MUST PLACE THESE BILLIONS IN A SPECIAL EDUCATIONAL TRUST FUND OUT OF THE REACH OF THOSE WHO WOULD DEPRIVE OUR CHILDREN OF BETTER

EDUCATIONS.

WE MUST TARGET OUR FUNDS TO IMPOVERISHED AREAS AND WE MUST IMPLEMENT SPECIAL PROGRAMS TO HELP EDUCATIONALLY DEPRIVED MINORITIES.

WE MUST ESTABLISH DEVELOPMENTAL AND EDUCATIONAL DAY CARE CENTERS ALL ACROSS THE NATION.

WE MUST EQUALIZE SPENDING AMONG SCHOOL DISTRICTS BECAUSE EQUAL FUNDING MEANS EQUAL OPPORTUNITY FOR OUR CHILDREN.

AND WE MUST USE EVERY TOOL AND EVERY RESOURCE AVAILABLE. LET'S NOT LOCK OURSELVES OUT OF ANY TOOL AND THAT INCLUDES REASONABLE AND COMMON SENSE BUSING. LET'S NOT GET HUNG UP ON BUSING.

LET'S NOT GET MISLEAD WITH THE THOUGHT THAT RACIAL BALANCE IS ACHIEVED THROUGH SOME KIND OF MATHEMATICAL FORMULA. WE DON'T BELIEVE IN QUOTA SYSTEMS.

LET'S LOOK AT REDEFINING SCHOOL DISTRICTS, TO ENFORCING HOUSING LAWS AND TO PROVIDING FULL EMPLOYMENT OPPORTUNITIES, THIS IS WHAT WE MUST DO IF WE ARE GOING TO TURN A CRISIS INTO A COMMITMENT TO PROGRESS.

I BELIEVE I'VE PROVED MY SINCERITY IN A QUARTER CENTURY OF HARD WORK. AND WHEN I SAY SOMETHING TO YOU -- WHEN I PLEDGE SOMETHING -- I MEAN IT.

I CAN PLEDGE TO YOU:

-- No more haynesworths and Carswells on the Supreme

-- NO MORE JOHN MITCHELLS AND HIS CRONIES IN THE JUSTICE DEPARTMENT.

-- NO MORE GAMES WITH THE CIVIL RIGHTS OF ALL AMERICANS BY AN ADMINISTRATION THAT DOES NOT CARE.

-- AND NO MORE RICHARD NIXONS IN THE WHITE HOUSE.

AND I PLEDGE TO YOU THERE ARE THINGS WE MUST DO:

-- WE MUST MEET THE NEEDS OF OUR CHILDREN WITH SERVICES

THAT WILL DEVELOP THEIR FULL AND TOTAL POTENTIAL.

-- WE MUST REBUILD OUR CITIES WHICH ARE ROTTING FROM

WITHIN.

-- WE MUST PUT AMERICA BACK ON ITS FEET BY PUTTING MORE THAN FIVE MILLION AMERICANS BACK TO WORK. - 15 -

-- We must guarantee that we will have clean Air, pure water and unravaged land everywhere in America -- not just in the parks and forests, but in the cities of this land. Above all, we can't look back. We can't stand still. There is only one way to go -- and that is forward.

I SAY TO YOU THIS ADMINISTRATION IS NOT GOING FORWARD. THIS ADMINISTRATION HAS TRIED TO TURN BACK THE CLOCK OF CIVIL RIGHTS PROGRESS.

IT HAS TRIED TO TURN BACK THE CIVIL RIGHTS CLOCK ON EQUAL HOUSING, ON VOTING RIGHTS, ON JOBS.

AND I SAY TO YOU THAT RICHARD HIXON, SPIRO AGNEW, AND JOHN MITCHELL CANNOT TURN THE CIVIL RIGHTS CLOCK BACK -- NOT ONE SECOND, NOT ONE MINUTE, NOT ONE HOUR. WE WON'T LET THEM GET AWAY WITH IT.

TOGETHER, YOU AND I ARE GOING TO WIND UP THE CIVIL RIGHTS CLOCK AGAIN -- AND FOR RICHARD NIXON HIGH NOON WILL

BE ELECTION DAY, NEXT NOVEMBER.

INSERTO IN SPREAME DAY

IN 1970 PRESIDENT NIXON VETOED THE HEALTH EDUCATION AND WELFARE APPROPRIATIONS BILL WHICH CONTAINED \$1.26 BILLION FOR EDUCATION.

IN THAT SAME YEAR HE VETOED THE EDUCATION APPROPRIATIONS ACT--A \$4.4 BILLION BILL TO PAY FOR ELEMENTARY AND SECONDARY EDUCATION, PROGRAMS FOR THE HANDICAPPED, VOCATIONAL AND DEVELOPMENT EDUCATION, STUDENT LOANS AND LIBRARIES.

CONGRESS OVERRODE HIS SECOND VETO.

AND HIS 1972 EDUCATION BUDGET WAS A FULL \$50 MILLION LESS THAN THE PREVIOUS YEAR'S BUDGET AND HIS LATEST BUDGET IS ANOTHER \$137 MILLION LESS AID THAN LAST YEAR'S FOR THE OFFICE OF EDUCATION. AND AT A TIME WHEN NO SCHOOL OR COMMUNITY CAN AFFORD A REDUCTION IN FEDERAL AID, PRESIDENT NIXON WANTS TO CUT BACK BY \$177.5 MILLION AID TO FEDERALLY IMPACTED AREAS--AREAS WHERE FEDERAL INSTALLATIONS AND LARGE NUMBERS OF EMPLOYEES PLACE AN ESPECIALLY HEAVY BURDEN ON LOCAL SERVICES SUCH AS EDUCATION.

THE RESULT OF THIS ADMINISTRATION'S DISASTROUS EDUCATION POLICIES OF VETOES AND CUTBACKS IS THAT THE FEDERAL GOVERNMENT IS PAYING ONLY 7 PERCENT OF THE NATION'S PUBLIC EDUCATION COSTS, A SMALLER SHARE THAN THE GOVERNMENT WAS PAYING TWO YEARS AGO.
