WHAT'S IT GOING TO BE LIKE IF RICHARD NIXON IS RE-ELECTED
IN NOVEMBER?

WHAT'S GOING TO HAPPEN TO THE LABOR MOVEMENT? AND WHAT'S GOING TO HAPPEN TO THE AMERICAN WORKING FAMILY?

I DON'T HAVE A CRYSTAL BALL. BUT IF THE PAST 39 MONTHS

ARE ANY INDICATION OF WHAT COULD HAPPEN IN THE FUTURE, AMERICAN

WORKING FAMILIES AND THE LABOR MOVEMENT ARE GOING TO BE IN

FOR A TOUGH AND TIGHT 4 YEARS.

LET ME TELL YOU A LITTLE ABOUT WHAT'S HAPPENED UNDER 3 YEARS OF RICHARD NIXON:

--UNEMPLOYMENT IN JANUARY 1969 WHEN RICHARD NIXON TOOK

OFFICE WAS 2.7 MILLION OR 3.4 PERCENT OF THE LABOR FORCE.

LAST MONTH 5.1 MILLION AMERICANS OR 5.9 PERCENT OF THE LABOR

FORCE WAS LOOKING FOR JOB.

IF RICHARD NIXON CAN THROW 3 MILLION PEOPLE OUT OF WORK
IN HIS FIRST TERM, WHAT DO YOU THINK HE'LL DO IN HIS SECOND
TERM WHEN HE DOESN'T HAVE TO WORRY ABOUT GETTING ELECTED
AGAIN?

--IN JANUARY OF 1969 SIX MAJOR INDUSTRIAL AREAS OF THE UNITED STATES WERE CLASSIFIED BY THE LABOR DEPARTMENT AS AREAS OF "SUBSTANTIAL UNEMPLOYMENT."

BY MARCH OF 1972, 49 MORE INDUSTRIAL AREAS WERE ADDED TO THIS LIST. IF PRESENT TRENDS CONTINUE THE ENTIRE NATION WILL BE CLASSIFIED AS AN AREA OF SUBSTANTIAL UNEMPLOYMENT.

-- IN JANUARY OF 1969 ONLY 334,000 PERSONS WERE UNEMPLOYED FOR 15 WEEKS OR MORE.

BY LAST MONTH, THAT NUMBER HAD INCREASED TEN FOLD TO ALMOST 1.3 MILLION WORKERS.

HOW MANY OF THESE WORKERS CAN STILL COLLECT UNEMPLOYMENT
BENEFITS? OR BETTER YET, WHY SHOULD THEY BE UNEMPLOYED

AT ALL? WHAT WILL HAPPEN IN THE FUTURE MONTHS AND YEARS?

AND WITH INCREASING UNEMPLOYMENT FOR PROLONGED PERIODS

THIS ADMINISTRATION FOUGHT AGAINST LEGISLATION TO INCREASE

UNEMPLOYMENT COMPENSATION BENEFITS AND TO EXTEND ELIGIBILITY PERIODS ANOTHER 26 WEEKS.

--IN JANUARY 1969, 1.6 MILLION WORKERS WERE EMPLOYED PART-TIME BECAUSE FULL-TIME WORK WAS NOT AVAILABLE.

BY MARCH OF 1972, THAT NUMBER HAD INCREASED TO

2.4 MILLION AND IT'S GOING UP. MORE WORKERS ARE MOONLIGHTING

THAN EVER BEFORE--NOT BECAUSE THEY WANT TO, BUT BECAUSE THEY

HAVE TO. PART-TIME WORK MEANS LESS PAY AND LESS CHANCE FOR

ADVANCEMENT.

--IN JANUARY 1969, 20 MILLION WORKERS WERE EMPLOYED IN MANUFACTURING INDUSTRIES, IN STEEL MILLS AND IN FACTORIES.

BY MARCH OF 1972 ONLY 18.8 MILLION WERE SO EMPLOYED—
A LOSS OF BETTER THAN 1.2 MILLION JOBS. AND RIGHT HERE IN
THE PITTSBURGH AREA J&L STEEL JUST ELIMINATED 2,000 PERMANENT
JOBS. WHAT'S HAPPENING TO PITTSBURGH'S WORKING FAMILIES IS
BEING REPEATED IN ERIE, IN JOHNSTOWN, IN SCRANTON, IN ALTOONA
AND READING AND PHILADELPHIA.

WHAT KIND OF FUTURE WILL THESE PEOPLE HAVE UNDER RICHARD NIXON IN THE NEXT 4 YEARS?

-- IN JANUARY 1969, 9.9 MILLION PEOPLE WERE ON WELFARE.

BY OCTOBER OF 1971--THE LATEST OFFICIAL STATISTICS
SHOW 14.7 MILLION PEOPLE RECEIVING PUBLIC ASSISTANCE.

AND MR. NIXON SAYS HE HAS A PLAN FOR WELFARE REFORM?

UNDER THE REPUBLICANS MILLIONS WERE ADDED TO THE WELFARE

ROLLS WHEN THEY SHOULD HAVE BEEN ADDED TO PAYROLLS.

BUT THAT'S NOT ALL, FOR THE FIRST TIME IN 10 YEARS

POVERTY INCREASED IN 1970 BY 1.2 MILLION PEOPLE.

--IN JANUARY 1969, THERE WAS A FOREIGN TRADE SURPLUS OF SOME \$70 MILLION. BY 1971, THERE WAS A DEFICIT OF \$2 BILLION. THIS WAS THE FIRST ANNUAL DEFICIT SINCE 1893. TRADE DEFICITS MEAN MORE FOREIGN GOODS OVER HERE AND MORE FOREIGN JOBS OVER THERE.

STATISTICS CAN'T TELL THE WHOLE STORY. THEY ONLY OUTLINE THE DIMENSIONS.

THEY DON'T TELL US ABOUT THE WORKER WHO CAN'T MEET

HIS MORTGAGE PAYMENTS OR WHO CAN'T AFFORD TO SEND HIS CHILDREN

TO COLLEGE.

THEY DON'T TELL US ABOUT WIVES FORCED TO WORK SO THAT THE BILLS CAN BE PAID.

THEY DON'T TELL US ABOUT WHAT UNEMPLOYMENT MEANS,

THE CANCELLED INSURANCE POLICIES, THE UNPAID MEDICAL BILLS,

THE BANK LOANS AND THE WEEKLY FIGHT JUST TO MAKE ENDS MEET.

THEY DON'T TELL US THAT MANY AMERICAN WORKING FAMILIES ARE ONLY A PAY DAY AND A HALF AWAY FROM BANKRUPTCY.

IT'S CLEAR, ECONOMIC HARD TIMES ARE A FACT OF LIFE WITH
THE NIXON REPUBLICANS.

AND TOO MANY PENNSYLVANIANS KNOW THIS.

THIS IS WHY RICHARD NIXON MUST NOT BE ALLOWED TO SERVE IN THE WHITE HOUSE FOR ANOTHER 4 YEARS.
