ALL ACROSS OHIO PRICES HAVE BEEN GOING  
UP.

EVERYWHERE YOUR FAMILY GOES--THE SUPERMARKET,  
THE APPLIANCE STORE, THE SHOE STORE, THE DRUG STORE  
THE REAL ESTATE OFFICE--PRICES ARE ON THE RISE.  
ALONG WITH HIGH TAXES AND INFLATED DOLLARS, THEY  
DEVOUR YOUR PAY CHECKS.

AT THE SAME TIME THAT PRICES HAVE BEEN  
SKYROCKETING, NEWSPAPERS IN OHIO AND ACROSS THIS  
NATION HAVE BEEN FILLED WITH HEADLINES ANNOUNCING  
BOLD, NEW PRICE ROLLBACKS AND REFUNDS.

OHIO FAMILIES HAVE READ THESE STORIES, AND  
THEY ARE WONDERING WHEN THE HUNDREDS OF MILLIONS OF  
DOLLARS IN ANNOUNCED REFUNDS WILL BE ROLLING IN  
AND WHEN THE PRICE ROLLBACKS WILL BE TAKING PLACE.

I'LL TELL YOU: NEVER! THE DRAMATIC A

1. THE GOVERNMENT SHOULD GO TO COURT  
ON BEHALF OF CONSUMERS TO OBTAIN PRICE REFUNDS.
2. ENFORCEMENT OF UNJUSTIFIED PRICE INCREASES  
MUST BE TOUGH.
3. BIG BUSINESS SHOULD BE MADE TO  
ABSORB A GREATER SHARE OF COST INCREASES INSTEAD  
OF PASSING THEM ON TO CONSUMERS.
4. PRICE INCREASES SHOULD BE PUBLICLY  
JUSTIFIED.

SUBJECT: COPE DINNER

Bob and I found out that in order to get the price refunds that have been announced by the Price Commission, you have to go to court. We point this out in a cost of living speech. We believe you should hit hard on the theme that the administration is deceiving American families and if that they have to go to court to get refunds, the government should go to court for them. (We checked this out from the legal point of view and it is a responsible position.)

Other information: Most people at the dinner will be from the building trades. You should use "building a better America theme--homes, schools, hospitals, etc. "you fellows are builders of America and I want to build America too. You build with your skills and your hands--I want to build as your President by providing this country with the type of leadership that will get this country moving again."
