L YOU HAVE HELPED SEND FRITZ MONDALE AND

CITIZENS. I KNOW THEY SHARE MY DEEP CONCERN THAT INDIAN

PEOPLE NO LONGER BE FORCED TO FOLLOW A TRAIL OF BROKEN

TREATIES. IT IS ONLY IN RECENT YEARS THAT WE HAVE BEEN

ABLE TO TAKE SOME VERY IMPORTANT STEPS IN TURNING ASIDE

FROM THAT TRAIL, AND TAKE A NEW PATH TOWARD ESTABLISHING

FULL RECOGNITION OF THE HUMAN DIGNITY OF ALL OUR PEOPLE.

THE RESTORATION OF SELF-RESPECT LIES AT THE
HEART OF ALL THE LIMITED BUT HOPEFUL BEGINNINGS THAT

HAVE RECENTLY BEEN MADE ON THE LANDS OF THE RED LAKE BAND

AND THE MINNESOTA CHIPPEWA TRIBE, INCLUDING WHITE EARTH

AND LEECH LAKE, ON BEHALF OF SOME 8,300 PEOPLE IN THIS

DISTRICT ALONE.

REFLECTING A DEEP SPIRIT OF INDEPENDENCE,

MUTUAL-HELP HOUSING PROGRAMS WERE PIONEERED ON RED LAKE,

WITH EMPLOYMENT GENERATED THROUGH ITS COOPERATIVE FISHERY,

SAWMILL OPERATION, AND FENCEPOST FACTORY, HUD, BIA, SBA,

AND EDA ASSISTANCE ALL PLAYED A ROLE HERE. ECONOMIC

DEVELOPMENT ADMINISTRATION AID HAS ALSO HELPED SPUR THE

TOURISM PROJECT AT LEECH LAKE, AND COMBINED WITH SBA

LOANS, HAS ENABLED THE RELOCATION OF WATERBURY FURNACE

COMPANY TO THE WHITE EARTH RESERVATION. FURTHER SBA

FINANCIAL AID AT WHITE EARTH HAS LED TO THE MANUFACTURE

OF ALL-TERRAIN VEHICLES.

THESE ARE BUT A FEW EXAMPLES OF THE COOPERATIVE

ROLE THAT THE FEDERAL GOVERNMENT OUGHT TO BE TAKING IN

ASSISTING THE TRIBES TO DEVELOP THEIR OWN LAND RESOURCES

AND ECONOMIC BASE. BUT IT IS A LESSON THAT YOUR

REPRESENTATIVES IN WASHINGTON HAVE HAD TO KEEP DRILLING

INTO THIS ADMINISTRATION MONTH AFTER MONTH. THE MOST

RECENT EXAMPLE OF THIS, ~~OF COURSE~~, IS THE PRESSURE THAT

FRITZ AND I AND BOB HAVE EXERTED ON THE DEPARTMENT OF

AGRICULTURE TO SUSTAIN WILD RICE RESEARCH, FOR WHICH THE

STATE LEGISLATURE HAS APPROPRIATED \$75,000, WELL

RECOGNIZING THE IMPORTANCE TO MINNESOTA OF PRODUCING

60 PERCENT OF ALL NATURAL WILD RICE HARVESTED IN THE WORLD

OVER THE PAST TEN YEARS.

AND LET ME JUST UNDERScore THE COMMITMENT OF OUR
STATE GOVERNMENT, BEING CARRIED OUT BY WENDY ANDERSON AND
RUDY PERPICH, TO MEETING THE HEALTH, EDUCATION, EMPLOYMENT,

COMMUNITY ACTION, AND ECONOMIC DEVELOPMENT NEEDS OF THE

TRIBES. THEY'RE ESTABLISHING A FINE RECORD. TO CITE

ONLY ONE EXAMPLE OF THEIR SENSE OF PRIORITIES: IN THE

ECONOMIC DEVELOPMENT PROGRAMS BEING ASSISTED THROUGH THE

UPPER GREAT LAKES REGIONAL COMMISSION, MINNESOTA HAS BEEN

THE ONLY STATE WITH INDIAN PROJECTS.!

BUT APPARENTLY THE NIXON ADMINISTRATION IS

STILL DETERMINED TO DO THE OPPOSITE OF WHAT IT PROMISES. D

WE'VE MANAGED TO BRING IN VITAL INDIAN HEALTH SERVICES AND

GET IMPORTANT NEW EDUCATION PROGRAMS FOR INDIAN CHILDREN

STARTED BUT SUBSTANDARD HOUSING REMAINS A CRITICAL

PROBLEM. YET WHAT DO WE HEAR FROM THE WHITE HOUSE?

L WELL, YOU HAVE THREE MEN HERE WHO DO NOT INTEND
TO SIT BACK AND TAKE "NO" FOR AN ANSWER. THE NIXON
ADMINISTRATION IS GOING TO LEARN THAT EVERY TIME IT STARTS
THAT LINE, IT IS GOING TO CONFRONT A TRIPLE-THREAT RESPONSE
FROM MINNESOTA.

L WE'RE GOING TO FIGHT FOR ADEQUATE FUNDING OF
RECENTLY ENACTED INDIAN EDUCATION PROGRAMS.

L WE'RE GOING TO TELL THIS ADMINISTRATION THAT
NO ONE WILL BE DECEIVED IF IT PROPOSES A BUREAU OF INDIAN
AFFAIRS BUDGET THAT IS, AT BEST, AT THE SAME LEVEL AS THE
CURRENT FISCAL YEAR -- BECAUSE SUCH A BUDGET WOULD FAIL TO
ALLOW FOR RISING COSTS, INCREASED SCHOOL ENROLLMENTS, A

RISE IN FAMILIES RECEIVING PUBLIC ASSISTANCE, OR THE

CRITICAL NEED FOR IRRIGATION PROJECTS, SCHOOL CONSTRUCTION,

AND THE PROTECTION OF INDIAN LAND AND WATER RESOURCES.

 I DO NOT INTEND TO LET THIS ADMINISTRATION HALT
THE HOPEFUL START MADE IN PRESCHOOL AND SPECIAL EDUCATION
PROGRAMS FOR INDIAN CHILDREN, WITHOUT A FIGHT.

 I DO NOT INTEND TO LET THIS ADMINISTRATION
CONTINUE TO CANCEL INDIAN HOUSING PROJECTS, EMPLOYMENT
TRAINING, TRIBAL WORK EXPERIENCE PROGRAMS, AND OTHER VITAL
NEW DIRECTIONS TAKEN BY CONGRESS TO ASSIST AMERICAN INDIAN
HUMAN AND RESOURCE DEVELOPMENT.

 I HAD THOUGHT THE ADMINISTRATION WOULD GET THE
MESSAGE WHEN THE SENATE IN THE 92D CONGRESS ENACTED A

MAJOR EXPANSION OF INDIAN EDUCATION PROGRAMS, AND

PASSED THE INDIAN SELF-DETERMINATION ACT AS WELL AS

SEVERAL MEASURES TO ASSURE THE EFFECTIVE USE OF TRIBAL

RESOURCES, SUCH AS THE TRANSFER OF FEDERALLY-OWNED

SUBMARGINAL LAND ON THE WHITE EARTH RESERVATION TO

THE MINNESOTA CHIPPEWA TRIBE.

↳ BUT APPARENTLY WE IN CONGRESS ARE GOING TO HAVE
TO SPELL IT OUT LOUD AND CLEAR NEXT YEAR, THAT THE TIME

HAS COME TO RESTORE PRIDE AND PROMISE TO INDIAN PEOPLE.

CONFERENCE TWELVE YEARS AGO IN THESE WORDS:

“WE BELIEVE IN THE FUTURE OF A GREATER AMERICA,
AN AMERICA WHICH WE WERE THE FIRST TO LOVE,
WHERE LIFE, LIBERTY, AND THE PURSUIT OF
HAPPINESS WILL BE A REALITY....”
