RIGHT NOW, WE ARE IN THE MIDST OF A DEMAND FOR EMERGENCY MEASURES. THE IMPOSITION OF A MANDATORY NATIONWIDE FUEL ALLOCATION POLICY IS ONLY ONE CASE IN POINT, BUT IT IS A PARTICULARLY VITAL REQUIREMENT FOR OUR WHOLE AGRICULTURAL PRODUCTION RESOURCE, FOR ESSENTIAL TRANSPORTATION SYSTEMS, AND FOR HEATING OUR HOMES, HOSPITALS, THE OWNER WATCHING AND SCHOOLS THIS WINTER. Almost 30 million people have left our Nation's farms and open countryside and moved to our cities and urban areas in just the last 30 years alone.
