FIRST, I WANT TO PAY SPECIAL TRIBUTE TO THE COALITION FOR EFFECTIVE RESETTLEMENT OF THE INDO-CHINESE REFUGEES FOR THE DEEP HUMANITARIAN CONCERN YOU HAVE DEMONSTRATED IN ASSISTING IN THE ASSIMILATION OF ALL INDO-CHINESE REFUGEES INTO OUR SOCIETY.

SINCE MAY OF 1975, NEARLY 150,000 REFUGEES FROM INDOCHINA HAVE BEEN RESETTLED IN THE UNITED STATES THIS IS THE LARGEST AND MOST RAPID REFUGEE RESETTLEMENT IN THE HISTORY OF OUR COUNTRY.

THE PRIVATE AND VOLUNTARY ORGANIZATIONS, RELIGIOUS GROUPS AND STATE AGENCIES WHO HAVE BEEN SO DEEPLY INVOLVED IN THE RESETTLEMENT EFFORTS ARE TO BE COMMENDED FOR THE JOB THEY

HAVE DONE,

WE ARE A NATION OF IMMIGRANTS AND THOSE WHO HAVE BEEN INVOLVED IN THE INDO-CHINESE REFUGEE ASSISTANCE PROGRAM REPRESENT THE FINEST TRADITIONS OF OUR COUNTRY. L HOWEVER, WE DO HAVE PROBLEMS WE ARE ON THE VERGE OF TURNING OUR BACKS ON THESE REFUGEES AFTER ONLY TWO SHORT YEARS OF FEDERAL HELP. THE INDO-CHINESE REFUGEE ASSISTANCE PROGRAM IS SCHEDULED TO BE TERMINATED IN OCTOBER OF THIS YEAR YET, MANY REFUGEE FAMILIES STILL ARE IN NEED OF HELP. THE INDO-CHINESE REFUGEES HAVE ACHIEVED A REMARKABLE RECORD OF ASSIMILATION INTO OUR SOCIETY. THE INDUSTRIOUSNESS AND SKILLS THEY BRING TO THE UNITED STATES IS EVIDENCED BY THE FACT THAT LAST FALL 87 PERCENT OF THE REFUGEES IN THE LABOR FORCE WERE

EMPLOYED.

By LAST FALL, 41 PERCENT OF THE REFUGEES WERE RECEIVING A TOTAL HOUSEHOLD INCOME OF MORE THAN \$9,500. THIS WAS ONLY 18 MONTHS AFTER THE REFUGEE PROGRAM WAS LAUNCHED IN THIS COUNTRY -- A MOST IMPRESSIVE RECORD BY ANY STANDARDS. MANY OTHER REFUGEES CAN MAKE THE SAME POSITIVE CONTRIBUTIONS TO OUR SOCIETY CHEY ARE PROVIDED WITH THE NECESSARY 5 TRAINING AND ASSISTANCE. THE 13 PERCENT UNEMPLOYMENT FIGURE AMONG THE REFUGEES DOES NOT REFLECT THE MANY SINGLE PARENTS, UNSKILLED VETERANS AND OLDER WORKERS WHO ARE NOT NOW IN THE LABOR FORCE BECAUSE THEY ARE RECEIVING INTENSIVE LANGUAGE TRAINING AND/OR VOCATIONAL TRAINING THEY CAN, AND WILL, BECOME PRODUCTIVE MEMBERS OF OUR SOCIETY IF GIVEN THE TIME TO ACQUIRE THE LANGUAGE AND VOCATIONAL SKILLS WHICH WOULD ALLOW THEM TO DO SO.

IN ORDER TO SUCCESSFULLY COMPLETE THE RESETTLEMENT PROCESS AND AVOID LONG-TERM DEPENDENCY OF THESE REFUGEES ON PUBLIC ASSISTANCE, IT IS ESSENTIAL THAT THESE SPECIAL FINANCIAL, EDUCATIONAL AND SUPPORT SERVICES BE CONTINUED THOSE OF YOU INVOLVED IN THE RESETTLEMENT EFFORTS, AND THE REFUGEES THEMSELVES, RECOGNIZE THAT THESE EFFORTS SHOULD NOT CONTINUE INDEFINITELY. ED PHASE-OUT OF SPECIAL SERVICES IS NECESSARY A PLAN TO PREVENT EITHER AN UNWANTED INSTITUTIONALIZATION OF SPECIALIZED SERVICES OR AN UNNECESSARY BURDEN OF UNEMPLOYMENT AND WELFARE FALLING UPON THE STATES AND UPON THE REFUGEES THEMSELVES.

THEREFORE, THE PROPOSAL OFFERED BY THE COALITION IS BOTH REASONABLE AND PRACTICAL. IT CALLS FOR THE CONTINUATION OF EXISTING FEDERAL FUNDING FOR CASH ASSISTANCE, MEDICAL ASSISTANCE, SOCIAL SERVICES, AND EMPLOYMENT AND TRAINING PROGRAMS OVER THE NEXT THREE YEARS, FUNDING FOR THESE SERVICES WOULD BE PHASED OUT SO THAT, BY THE END OF THE THREE YEARS, INDO-CHINESE REFUGEES WOULD BE ELIGIBLE FOR SERVICES ON THE SAME BASIS AS OTHER U.S. RESIDENTS. I ALSO AM A CO-SPONSOR OF LEGISLATION WITH SENATOR EDWARD KENNEDY WHICH WOULD ALLOW THE INDO-CHINESE TO ADJUST THEIR 1L STATUS FROM PAROLEE TO PERMANENT RESIDENT ALIEN WITHOUT REFERENCE TO THE QUOTA LIMITATION.

THIS MEASURE WILL REMOVE A SERIOUS OBSTACLE TO THE FULL ASSIMILATION OF INDO-CHINESE REFUGEES IN OUR SOCIETY. THE COALITION'S PROPOSAL, WHICH IS SUPPORTED BY THE INDO-CHINESE REFUGEE COMMUNITY, IS NEEDED, SOME 16 YEARS AGO, THE U.S. GOVERNMENT LAUNCHED THE CUBAN REFUGEE PROGRAM. TODAY --16 YEARS LATER -- WE STILL ARE PROVIDING DADE COUNTY, FLORIDA, \$90 MILLION A YEAR IN SUCH ASSISTANCE. A THREE-YEAR PHASE-OUT OF THE INDO-CHINESE REFUGEE PROGRAM CERTAINLY IS A MOST REASONABLE PROPOSAL AND WORTHY OF THE SUPPORT OF OUR GOVERNMENT. HAVE SPOKEN WITH PRESIDENT CARTER ABOUT THIS AND I FEEL CONFIDENT HE SHARES MY CONCERN THAT THE INDO-CHINESE REFUGEE ASSISTANCE PROGRAM SHOULD BE CONTINUED IN ORDER TO COMPLETE THE FULL ASSIMILATION OF THESE INDUSTRIOUS PEOPLE INTO OUR SOCIETY.

I ALSO HAVE WRITTEN THE DIRECTOR OF THE OFFICE OF MANAGEMENT AND BUDGET TO EXPLAIN THE NEED FOR CONTINUATION OF THE PROGRAM OVER THE NEXT THREE YEARS, AS A FOLLOW-UP TO MY CONVERSATION WITH THE PRESIDENT.

You can be assured that I personally will sponsor the Administration's proposal to continue this program when it is READY FOR CONGRESSIONAL CONSIDERATION.

IN APPROACHING MEMBERS OF CONGRESS AND OFFICIALS IN THE Executive branch to gain support for the Coalition's proposals, Would let the facts speak for themselves.

EIGHTY-SEVEN PERCENT OF THE REFUGEES ALREADY ARE EMPLOYED

IN THE LABOR FORCE.

Some 41 PERCENT OF THE INDO-CHINESE HOUSEHOLDS HAVE INCOMES OF \$9,500.

L THE UNITED STATES GOVERNMENT, AFTER 16 YEARS, IS STILL PROVIDING \$90 MILLION ANNUALLY FOR THE CUBAN REFUGEE PROGRAM. WHAT THE INDO-CHINESE REFUGEES WANT, AND WHAT THE COALITION SUPPORTS, IS A THREE-YEAR EXTENSION OF THIS PROGRAM IN ORDER TO COMPLETE THE ASSIMILATION OF THE LARGEST INFLUX OF REFUGEES AT ANY GIVEN TIME IN OUR NATION'S HISTORY.

I THINK THE MERITS OF THE CASE ARE STRONGLY ON YOUR SIDE AND I THINK MEMBERS OF CONGRESS WILL BE GENUINELY SYMPATHETIC TO YOUR CAUSE IF THE CASE IS OUTLINED IN THIS MANNER.

I CERTAINLY WILL DO ALL I CAN TO SEE THAT THE THREE-YEAR EXTENSION OF THE PROGRAM IS ACHIEVED.
